Introduction About Childminding UK

Childminding UK has been supporting childminders for over 30 years. Formed in 1991 by and for local working childminders in Northamptonshire, we now support childminders across the country. A registered charity, we are the only national organisation that solely supports childminders and we have achieved the Princess Royal Training Award for 'Ensuring high quality childcare through training and support'.

Part one Background

It is widely recognised that the first 5 years of a child's life are fundamental to their future chances, both in education, their opportunities for employment and building and maintaining effective relationships. It is vital that good early years education focusses on the needs of the children at all times.

We know that there are two main factors that constitute good quality care and education. This is the qualification and training levels of adults and those all-important adult-child interactions.

The government expansion of what they term 'FREE' childcare, is aimed at encouraging and enabling more parents to work and will provide up to 30 hours of funded childcare to children over the age of 9 months for eligible families. It is estimated that £28 billion would be generated for the economy if more women were able to work.

To enable parents to work, there needs to be sustainable, good quality and affordable childcare available. But childcare is not available evenly across the country - there's more in affluent areas than less affluent areas. We also have an unprecedented decline in the availability of childcare places. Last year alone, we lost 3,500 childminders and 400 group settings, with large percentages of the current workforce saying they are considering leaving within the next year.

Cathy Nutbrown, along with many others, states that early years is undervalued and underpaid. The Government's 'FREE' childcare offer only covers two thirds of the cost of providing a place, but parents are prevented from being charged the difference, which is putting childcare settings at risk of closure. Many are worried about the roll out to all children over the age of 9 months because currently it is the additional hours and younger children which keeps settings viable. Some childminders are telling us they will have to close as they can't survive if all children receive funding. Others are saying they won't provide funded places but will only offer private places.

We know that staff are 4 times less likely to leave early years if they can access training, but Local Authorities training and support has been reduced by around 80%. Settings have to source and pay for their training and support - which many are happy to do, but they need to be able to afford to.

Part two Methodology

Childminding UK currently has almost 1,300 members. We invited members and non members to complete a survey from the beginning of November until 11th December 2023 and received 424 responses.

The focus of the survey was on:

- How many childminders provide funded places
- If childminders limit the number of funded places they offer
- How many childminders request voluntary payments or consumables payments
- If childminders are worried about the sustainability of their provision as the childcare expansion is rolled out to all eligible children over 9 months of age
- What is needed to enable childminders to remain sustainable.



Part three **Key findings**

Providing funded places

87.2% of respondents currently provide funded places. Of the **13%** who don't, **20.3%** said they would consider providing funded places if the funding rate was adequate. Others suggested they would provide funded places for 2 year olds and under but not 3 and 4 year olds as the payment is less and therefore not sustainable.

Limiting the number of funded hours in a day

Currently, only **19.9%** of respondents limit the number of funded hours available during the day, with **68.3%** not limiting at all. Some respondents stated that they must do this to remain sustainable or that they will introduce limits when the expansion is rolled out otherwise they won't survive.

Voluntary contributions or charges for consumables

Currently **50.8%** of respondents request a voluntary contribution to childcare costs and **49.5%** charge for consumables.

Childminders worried about sustainability

62.4% of respondents are worried about the sustainability of their childminding setting when the expansion is rolled out to all eligible children. Some cite the low hourly rate that doesn't meet their usual rates, but many also citing that their Local Authority only pays termly and they can't survive unless payments are monthly.

Part four Survey results

The survey results paint a clear picture of childminders who want to provide a childminding service but feel that government funding and processes threaten their very existence as childcare professionals. We received an unprecedented number of comments from respondents which clearly explain their frustrations and barriers to continuing in a job they love. Those childminders in receipt of Universal Credit (UC) are reporting that the HMRC allowances for childminding expenses are not recognised by Universal Credit, meaning childminders losing out.

A widespread concern highlighted is exampled here. "I am extremely worried. I am a single parent minder with two assistants and have just been moved from Tax Credits to Universal Credit. Our funding is paid in two lump sums per term rather than monthly. Funded months will wipe out my UC completely even though the funding covers 2-3 months of expenditure. In non-funded months I will then get below minimum income floor income so will lose UC help then too. UC do not work to the same rules as HMRC. I am already £600 a month down and will be over £1000 a month down when all get funding. My beloved Outstanding setting will most likely close. "

Others say that their local authority only paying termly or twice termly, means they are not eligible for Universal Credit payments those months.

"With Birmingham City Council only paying termly for funding I financially cannot afford to offer more than 1 space as the bulk payment effects my universal payments leaving me short in money to pay essential bills. One respondent was told by Universal Credit advisors to look for other employment. "As funding is only paid for 38 weeks per year I cannot have feasible self-employment with filling my spaces with 3 children and getting paid only 38 weeks of the year at £5.14 it doesn't even meet MIF for Universal Credit, then Universal credit says I need to find different job!"




Providing funded places

87% of respondents currently provide funded places. Of the **13%** who don't offer funded places, **7.3%** of respondents have suggested they will not offer funded places, even when the expansion is fully rolled out. For the remainder, they are watching and waiting to see what the hourly rate is before committing or waiting to see if their Local Authority will pay them monthly instead of termly so they can afford to.

"As we can only have a maximum of 3 children, the rate for 3 year olds is too low. Once outgoings are paid, I would be working for less than minimum wage. I would only be able to do it for the lower age ranges. I enjoy working with the older age range so it's unlikely I would childmind for much longer knowing they will have to leave when they turn 3"

"If we could deduct the funded amount from our fees then yes. Not being allowed to charge the difference, even though we are self-employed, can decide the amount of funded spaces we can afford to offer."



Limits to the number of places on offer

16% of respondents already limit the number of funded places they offer and give a variety of reasons for doing so. Reasons given include practicalities such as needing to take time off for dentist appointments which they say is not permitted with funded places, the amount of time the additional admin takes to provide funded places and also the financial implications of being able to provide both private and funded places in order to be financially viable as the 'non funded' children keep the business afloat. One voiced a common concern "I cannot afford all the children to be funded".

All but one respondent reported that the hourly rate is below what they usually charge. Some said that as self-employed people, they believe they should be able to set their own fees. "If this is going to be available to all children from 9months to 4yrs it will be dependent on hourly rate offered - as being self-employed I should be allowed to choose my own hourly rate to ensure my own sustainability".

"If I offer funded spaces, I feel to be financially sustainable I will be forced to limit spaces available."

"The funding rate is a lot lower than my hourly rate so to offer all funded places would not be sustainable".

"I do not currently limit funding but with funding coming in I will not be taking children that want only finding hours as the additional hours will be what makes the place sustainable and cover business costs"

For some childminders, they have already made the difficult decision to close. "I have decided to stop childminding entirely when it comes in".

"Financially I need to make my business profitable I cannot operate as a charity I need to keep a roof over my own children's heads".

Limiting the number of funded hours in a day

A slightly higher figure of **19.8%** already limit the number of funded hours available in a day, with **68.4%** not limiting at all, but enabling parents to access the hours they need. More though are considering introducing this limit if they are to remain sustainable, with increased fees for non-funded hours.

"Not at present, but with the new scheme coming in from next year, I'm seriously considering it due to very poor funding rates".

"Going forwards I intend to fully limit this further to ensure I don't financially suffer - currently our LA doesn't pay monthly and the rate is lower than what I charge".

"Not at present but I intend to when the full funding for all children from 9 months comes into play".

"I do either 7.5 hours a day or 10 hours a day of funding, there is no 'pick n mix' option available as the admin burden of funding is far greater than just invoicing fee paying parents. I also do 'whole' days of childminding, not half days".

"I feel it's sad that childcare providers have to manipulate the funding system in order to get a fair income. The issue is in both the funded rate being lower than the standard space rate, plus huge issues around funding not being paid in the month that the actual care takes place in line with UC requirements".

The stretched offer

Most respondents (**42.8%**) provide funded places during term time with parents paying in full during school holidays. Some state that holiday payments enable them to be sustainable. Many offer both term time and stretched offers depending on parents requirements. Others report difficulties with complicated local authority admin requirements which they say limits what they will offer parents, or **9.9%** who say local authorities who won't permit the stretched offer. One stated "Our LA will not allow us to offer stretched".

Until now I have allowed parents to stretch funding but it is too complicated and I fear losing out financially if a child leaves - so I'm considering no longer offering the option to stretch."

"The system for claiming is so complicated I can't afford the time spent trying to work out funding and invoices"



Voluntary payments and charges for consumables

The government guidance for local authorities makes it clear that early years settings are not permitted to charge top up fees to make up the difference between government payments and settings usual fees, but they can make charges for consumables as long as charges are voluntary and not compulsory. Our survey results showed that **50.6%** of respondents requested a voluntary payment and **49.5%** requested a consumables payment. Most introducing voluntary payments called them either voluntary or sustainability payments and **43.6%** have a set amount per hour and **28%** per day. **67.8%** of respondents set a set consumable charge per child with **32.2%** setting it according to the individual child.

"My parents pay a flat voluntary contribution of £60 per week. This is specifically to cover travel, dance class, zoo pass, theatre and forest school experiences all which are additional to our core EYFS delivery. Some parents volunteer not to pay the contribution, some offer to pay a proportion of what is requested according to their means."

"I explain that the funding amount is less than my hourly rate and ask for a voluntary payment to cover the difference otherwise I will struggle to provide the experience I would like for the children in my care."

"Additional educational enrichment & consumables including food (it's one amount) not shown separately from food / consumables."

Most respondents say that the majority of parents are happy with making the payments, and only **6.1%** of prospective parents refusing and **6.4%** of existing parents. When this happens, childminders have reported they fund this out of their own pocket, or do not offer the place to the child, explaining to parents that they can't afford to.

"It's important to understand why a family is unwilling or unable to pay. Honest open, compassionate approach is required. Children should never be disadvantaged or left out if their parent cannot pay. Often the cost of the trips in this circumstance comes directly out of my own wage. I would not discriminate against a child on the basis of affordability of a voluntary contribution"

"I tell them it is also voluntary to offer funding so I fill the space with someone else who is supportive of my business."

"Nothing we still offer space and just make a loss on the hours."

"I simply explained the figures and what we would lose over the year and that it wasn't free but subsidised, she owned a business and I asked her if she would do a job for a reduced rate and her answer was no - she wouldn't."

"Some parents are not in a situation to be able to pay the voluntary contribution . For example I have been supporting a parent who is very young and is trying to survive."

"Parents know I can only offer funded hrs if that pay a voluntary/ consumables fee to top up the hourly rate to meet what I normally charge. The fee includes meals, snacks, outings, nappies and wipes. My parents know I cannot sustain without that support. I wouldn't be able to offer funded hrs. My business would end after 17 years of something I've put my heart and soul into."

"Parents have been happy to pay a consumable fee. Most have already been paying my rate of £5.50 hour and are delighted with the saving."

Worries about sustainability as the programme is rolled out

62.5% of respondents state they are worried about sustainability as the programme is expanded, with only 25.7% saying they aren't because they will continue to charge a consumables fee that covers the difference. Many name the hourly rate being less than their usual and others are concerned about the payments being termly and that this affects Universal Credit payments but also the delay in payments makes it untenable to pay their own monthly bills if there are no privately funded children to allow some income regularly. Most respondents state that if they were permitted to charge a simple top up fee, they would be able guarantee sustainability of their service.

"It's not very helpful for childminders as the payment is quarterly and I don't pay my bills and rent quarterly".

"Very poor funding rates will make it harder to stay sustainable. I've took the bullet by not charging any additional fees, but with more children being eligible to funding, I won't be able to carry on in this way"

"The funding process is time consuming as a childminder, the LA contract is weighted in the parent's favour not setting with notice periods / deposits etc. The funding isn't paid in advance and the difference between funding amount and private fees is widening for 3&4 year olds. The parents have to be in a position where they are able to pay extra for educational trips, consumables and food as otherwise I can't afford to put myself into poverty for the parent's financial gain."

"I am a single mother soon to be transferred to universal credits. Being paid a lump sum once a term will wipe out any payments I should receive from U.C, plunging me into very real poverty. Unless Hertfordshire agree to monthly payment, I will have no choice but to close my business"

"I don't really like being fully dictated what we will be paid when we are self employed and have no benefits of being employed (holiday pay, sick pay etc)."

"As a childminder on universal credit as I am a widow with 3 small children getting paid 6 times a year is difficult as I have to pay my bills myself weekly then universals credits say I can't claim until my money runs out in which they will top up but I will have zero income as my weekly money has ran out, that and the fact we can not claim for gas electric water council tax, the only reason I heat my home 40 hours per week is for children, it's forcing me to give this job up".

Reported lack of information or late information from Local Authorities makes it harder for childminders to plan and budget for childcare places.

"The lack of information especially in a timely manner is the problem with the amount the LA are going to pass on and whether this amount is going to remain the same, lower or higher each term or financial year. It is impossible to budget and set fees when the LA only announced what they were paying for this autumn term mid September, when children had already started and there is no guarantee it is going to remain the same for summer term. I wonder if it is still really going to go ahead and whether the government will change and it will all change. The free is the issue, having government funded contribution towards childcare wouldn't be a problem. "

The survey identified many objections to the use of government language in allowing parents to think places are free when they are 'subsidised' and not fully funded.

"Please don't use the word free even in dittos, it is a subsidised funding"

"The word "Free" makes the parents believe it is a god given right for childminders to care for their children for Free! It's not free! The government should in fact call it subsidised funding and parents should be made to understand that we don't work for free or for the amount the government deems we are worth. We are losing childminders at an unprecedented rate and the government only wants to help the parents to return to work. Making life better more financially beneficial for them. I have families with both parents working earning double my monthly wage and they are pleading poverty!!"

The following 2 comment sum up the strength of feeling among many respondents.

"Why have you written FREE in capital letters, if you had any idea how infuriating this is to our industry you wouldn't even call it free, it's not free it's under funded and the childminder has to take the punch for the 'free' portion that the government doesn't cover, it's not free it's at a small businesses expense that the government exploits. Sustainability is already strained, if this additional funding offered to you for children is not covered properly by the government and local councils, many providers will close their doors, no one runs a business at a loss"

"For the government to say it's supplemented and not free. For the government to pay the parents rather than us as I'm self-employed and not a public sector worker. If I am a public sector worker now being paid by the government then I should be entitled to a pension. They have enforced a pay cut on me (which in any other company would be illegal) and then told me to make up the difference in order to be sustainable I must say it's voluntary. So I must now be a charity because the parents livelihoods are more important than mine. If they are concerned some parents can't pay then this should have been means tested. Why should I say a charge of £15 a day be voluntary in order to continue working at my present hourly rate when some of these parents earn just under 100k a year or more. What the government have done is completely underhand. They have forced us into a situation and if we can't afford to continue as a result, many childminders and nurseries will close and then there won't be any childcare available at all. So governments plan to get more people to work will just backfire and put us out of work and many unable to work. It appears for the 2 year provision they will pay enough to cover our hourly rate but for children over 3, this won't be the case. Many childminders may even choose not to care for them when they turn 3 because they simple can't afford to."

With shortages of childcare places currently and predicted to get worse, one respondent raised concerns about vulnerable 2 year olds accessing a funded place.

"Not enough settings to provide care. Quality will suffer. Differing rates will make it hard for us to budget AND provide continuity of care for older children who need a small setting. Disadvantaged 2 year olds will get pushed out as easier to offer 30 hours rather than 15".

Part five Summary & Recommendations

The responses to this survey show how strong the feelings and frustrations are among the childminders who responded to the survey, many of whom state they are being forced to give up a job they love and have put 'their heart and soul into'.

Childminding numbers have reduced significantly over the last few years and according to our survey, Childminding UK is saddened to see that many more are planning to cease trading due to the expansion of what the government call 'free childcare places'.

We know that the amounts of funding the government set for their 'free places' is determined by nursery ratios which are very different to childminding ratios. For example, the rate for 3 and 4 year olds is set at the ratio of 8 children per adult, but childminders are not permitted to care for 8 children. Childminders are saying they are having to consider only caring for younger children which would disrupt the continuity of care that is so important for young children.

The introduction of start up grants to encourage more to register will only work long term if childminders can afford to keep the job they are registered to do.

The majority of respondents are requesting a voluntary or 'sustainability' payment, to bring the funding rates up to their usual hourly rate in order to survive and provide the high-quality provision they want to, with many reporting that parents are happy to pay. Others are stating that some parents are refusing to pay, which is leaving childminders out of pocket and threatening the future of their setting or leaving childminders no choice but to not offer a funded place to the child.

Others are limiting the funded hours in a day or week so that parents pay for some privately funded hours too and these hourly rates are set at a level to supplement the funded shortfall. These privately funded hours will largely cease to exist after the expansion is completed, apart from childminders who tell us they will only offer private places.

Part five Summary & Recommendations continued...

Most respondents state that if they were simply permitted to charge a top up fee, they would be sustainable and that parents wouldn't expect their child's place to be free. For this to happen, the government would need to change the narrative from 'free places' to 'subsidised or part funded' places.

Early Years has several types of setting, from nursery schools who have to employ and pay teachers, chain nurseries in purpose-built buildings, independent pre-schools operating from village or church halls and childminders operating from home, all with differing running costs, ratio requirements and different fees for parents. Childminding UK believes that the government has a difficult task if it is trying to set one hourly rate that will pay each setting what they need to without over paying or underpaying others, and that changing the narrative and permitting settings to charge a top up fee would be a fair way for parents to understand the government contribution but allows them to choose the setting the feel is best for their child.

Although not a survey question, we heard from childminders who feel it is unfair they can't claim funding for related children as they do in Wales and is permitted in group settings in England.

A slightly lower percentage than expected said that they are concerned the roll out childcare places will threaten the sustainability of their business. This may be due to the high number of childminders who are already successfully receiving voluntary payments from parents and plan to continue. It is saddening to hear from so many that are planning to close their business who may continue to thrive if the rules and guidance were changed.

Local Authority processes and delays in payment and information being relayed to childminders is cited as causing difficulties in childminders future planning, but also causing financial hardship with one respondent waiting over 6 months for payment. Childminders have families to support and need to be able to rely on the income from their business. For those respondents on Universal Credit, the differences in childminding expenses that are accepted by HMRC and Universal Credit is causing childminders to lose essential benefits.

Recommendations


- Increase the amount of funding to fully cover the cost of a childcare place, or change the narrative around what the government call 'free' childcare places to 'subsidised places' so that parents are aware the funding doesn't cover all the costs of a childcare place
- Allow providers to charge a top up fee to cover any shortfall in government payments
- Ensure that all Local Authorities offer monthly payments to childminders
- Set time-scales for Local Authorities to inform providers of future funding rates
- Require Local Authorities to have a robust but simple to operate platform for claiming for funded children
- Align the childminding expenses that are allowable with HMRC to Universal Credit claims to prevent childminders losing benefits
- Set funding rates for childminders based on childminder ratios and not nursery ratios
- Enable childminders to claim funding for related children as they do in Wales and as nursery counterparts can.



"Funding doesn't cover my daily rate so if was to offer funded hours full days would be at a loss for my business with cost of food and resources and trips"



The government should in fact call it subsidised funding and parents should be made to understand that we don't work for free or for the amount the government deems we are worth. We are losing childminders at an unprecedented rate and the government only wants to help the parents to return to work. Making life better more financially beneficial for them. I have families with both parents working earning double my monthly wage and they are pleading poverty!!"

"I've worked very hard still don't charge as much as x nursery but the Government under pay I can't afford to drop money"

Funding needs to change to matching our hourly rate and being paid monthly, so many child minders are giving up and nurseries are closing because all of the expenses we have are going up but funding isn't. Those of us who employ people their wages aren't even quite covered by having 2 funded children, and each child has an expense to look after too. The system is failing us all."

"What will happen to those who get an inadequate or requires improvement. As in our area you have to have above these grades"

"I am a single mother soon to be transferred to universal credits. Being paid a lump sum once a term will wipe out any payments I should receive from u.c, plunging me into very real poverty. Unless Hertfordshire agree to monthly payment I will have no choice but to to close my business"

"I am a small setting and only have 2 children plus my son. I currently earn under minimum wage, if the funding amount actually creates a working wage for childminders this will be a good thing. My charge is £5 an hour and funding rate is £4.65 so hopefully it will improve this."

"I'm not sure. I think there will not be enough childcare as parents that are not working and do not currently need childcare will take up the opportunity to use their FREE hours. I have already had enquiries.

The biggest problem will be payment budgeting. I get paid monthly and if this is now paid termly although a lump sum is nice is also tempting to spend therefore run out by the end of the term."

"Mainly due to how universal credit look at our earnings. It's not the same as tax credits or even HMRC. We can only claim flat rates for expenses regardless of how much we spend. And they don't understand we don't get paid monthly."

'Personal details removed' said:

"Why have you written FREE in capital letters, if you had any idea how infuriating this is to our industry you wouldn't even call it free, it's not free it's under funded and the childminder has to take the punch for the 'free' portion that the government doesn't cover, it's not free it's at a small businesses expense that the government exploits. Sustainability is already strained, if this additional funding offered to you get children is not covered properly by the government and local councils, many providers will close their doors, no one runs a business at a loss"

"I'm concerned that elements of our contacts will not be honoured and we'll be left in financial difficulty. Funding follows the child, so if a parent takes a child out without any notice we're left with no pay."

"We provide a free breakfast for all children (Early years and School children) if required. All Early Years parents provide their child with a lunch box, wipes, nappies etc. Any theatre/farm/zoo trips and groups we choose to take the children, we fund as its our choice to offer these things. We hope that above all, this Government Scheme will help the parents"

I wonder if it is still really going to go ahead and whether the government will change and it will all change.

The free is the issue, having government funded contribution towards childcare wouldn't be a problem."

"Business Funding And Rates Childminders or Childcare Practitioners can Charge"

'Personal details removed' said:

"Rather than "free" childcare, it should be called "subsidised", to show it as a contribution towards the cost."

'Personal details removed' said:

"About the payment and much government is going to pay per child"

'Personal details removed' said:

"Better rates than the ones we have at the moment"

'Personal details removed' said:

"For the government to say it's supplemented and not free. For the government to pay the parents rather than us as I'm self employed and not a public sector worker. If I am a public sector worker now being paid by the government then I should be entitled to a pension.

They have enforced a pay cut on me (which in any other company would be illegal) and then told me to make up the difference in order to be sustainable I must say it's voluntary. So I must now be a charity because the parents livelihoods are more important than mine. If they are concerned some parents can't pay then this should have been means tested. Why should I say a charge of £15 a day be voluntary in order to continue working at my present hourly rate when some of these parents earn just under 100k a year or more between them.

What the government have done is completely underhand. They have forced us into a situation and if we can't afford to continue as a result, many childminders and nurseries will close and then there won't be any childcare available at all.

So governments plan to get more people to work will just back fire and put us out of work and many unable to work.

It appears for the 2 year provision they will pay enough to cover our hourly rate but for children over 3, this won't be the case. Many childminders may even choose not to care for them when they turn 3 because they simple can't afford to."

"The funding per hour for 3 year olds needs to be at least £8 an hour"

Not all three year olds go to nursery there aren't the places. I feel this will encourage childminders to take younger children for the money. We have been under funded for to long."

"That the LA do not change the goal posts for consumable charges. I have seen some LAs say we cannot charge for Xyz as these are business costs. That the LA do not take away funding when a setting is 'deemed' inadequate by an inadequate Ofsted Inspector."

'Personal details removed' said:

"Exactly what we can charge for and making it clear to parents that funded hours are funded and not free."

'Personal details removed' said:

"The councils to hurry up and decide how much per hour per child so I can decide if it is viable or not"

'Personal details removed' said:

"better info better rates so no need to ask for voluntary payments."

'Personal details removed' said:

"Removing of free childcare label. More explanation to parents that:

1) the figure the government pay isn't what we get, our local authorities take a portion of the fee.

2) the funding doesn't our hourly rate."

'Personal details removed' said:

"Being allowed to ask more freely for a top up of payments.

Being given better tax advantages. For example, childcare children take up way more than a 10% of my water bills.

Calling the places subsidised, not free, would help manage expectations for parents.

Government agreement to pay as a minimum commitment the cost of the living wage of any employees. Early years educators ought to be paid like teachers not less than babysitters. We need help with staff retention and paying for theme it take to do training."

'Personal details removed' said:

"What the hourly rate will be per child, this will help me find out if I can offer funding and what ages I can offer it to"

'Personal details removed' said:

"We get very helpful support from our Early Years team."

'Personal details removed' said:

"Please stop calling it free child care, it isn't free"

'Personal details removed' said:

"I think if we paid individuals direct via the tax free scheme it would enable a lot more provider to sign up and be willing to be a FEEE provider. Alot of the data inputting and forms to fill out making us jump through hoops puts a lot of people bothering. I also think if the government and local authorities will start to prevent providers been able to request voluntary contributions, the scheme will fail. If I am told what I am paid and how I run my business, I will stop been self employed and go find a job that will pay me at least the pension within the boundaries they set"

'Personal details removed' said:

"Funding payments need to increase annually (average pay rise 5%) we have been paid less and less each year so far"

'Personal details removed' said:

"I need to know the amount the LA is actually going to pass onto per hour per child. The headline uplift figure for the 2 yr olds is nearly 1/3 less =£5 per hour less than the official DFE excel spreadsheet but that is only continuing to March. I need to know the funding rate for the whole academic or financial year, with plenty of time - at least 6 weeks ideally more so I can properly plan to make my business sustainable and put up fees. In my current situation I am likely to increase my fees dramatically to be able to accommodate the uncertainties of funding so my income remains relatively stable. It would be far easier to be able to continue to set my own all inclusive fees and the parents pay the difference off their whole invoice with the funding."

'Personal details removed' said:

"Rates our council will pay us released in plenty of time. We usually only get a few days notice, and in the past it has also been once the term had started. Also for the government to check that the council is not taking a bigger top slice than they are allowed ` this has happened in the past too"

'Personal details removed' said:

"Be nice to know exactly how much we are to receive so we can plan ahead with our families"

'Personal details removed' said:

"Needs to be paid monthly, we should be able to dictate own extra fees - we should be able to accept funding for family members"

'Personal details removed' said:

"Reduction in utility bills."

'Personal details removed' said:

"I would need the payment for care to be in the line with the cost of living."

'Personal details removed' said:

"not calling funded hours 'free' - timely information about what the rates are - locally, not an average!"

'Personal details removed' said:

"Exactly how much we will receive and if its paid monthly."

'Personal details removed' said:

"Needs to be made clearer it is not free, rate needs to be higher The amount we receive is 1/3 of national minimum wage"

'Personal details removed' said:

"Simplify the whole system. Joe to manage a reduction in rates from 2 to 3"

'Personal details removed' said:

"Actual hourly rate we will get 3nmintjs before so we can plan financially especially when employing an assistant"

'Personal details removed' said:

"The difference in my hourly rate and funded rate is currently £1.50.

I'm have only been charging a £1/hr voluntary payment so losing £30/week with 3 funded children."

'Personal details removed' said:

"A list of fees etc in chart by each borough"

'Personal details removed' said:

"always have children in the setting"

'Personal details removed' said:

"Funding payments need to be paid monthly not termly as this has a huge effect on those on benefits like universal credit"

'Personal details removed' said:

"Our biggest threat is Ofsted. They are deliberately targeting childminders and no-one is standing up to them.

We need support and protection from Ofsted and we need access to the same funding as nurseries and schools. Free breakfasts? Why can't childminders claim for it?

The free early years entitlement is a nursery concern. I'm sick of fighting their battles while they sacrifice us to Ofsted."

'Personal details removed' said:

"We need same amount for all ages as our ratios remain the same regardless of age"

'Personal details removed' said:

"We as childminders are supposed to be self employed which should allow us to offer our services at the price / fee that we feel our delivered services deserve - This Government scheme is taking the individuality of our unique services away and making us feel 'employed' and restricted by our Local Authority decisions"

'Personal details removed' said:

"What we can actually charge for. We should be able to charge a top up fee, parents are still getting help with fees through the funding, so to help keep settings we must add top ups!"

'Personal details removed' said:

"I'm looking elsewhere for employment in the new year."

'Personal details removed' said:

"Being kept up to date with the amounts paid to our local Authorities. Funding or grant support"

'Personal details removed' said:

"We need to know the rate for our area, everything will hang on that"

'Personal details removed' said:

"How I can legally charge patents a fee to ensure they pay the same rate for all other children. Info to give to parents to explain this and how the hourly rate is lower than my normal fee rate ...I speak to parents to explain this but literature to explain this would be very helpful ! And they can hopefully take it away and read it and not forget or dismiss what we have spoken about"

'Personal details removed' said:

"I wish they didn't call it free childcare.

More info on the actual rates and hoping the system we use can actually work, had new local authority system and it definitely hasn't worked ever time I have used it the computer people have to input it by hand.

I am dreading when the new two year olds come on that system.

I am glad that working parents are getting extra financial help but I am concerned about the very low rate for the 3/4 year olds one of the lowest in the country in Leicestershire"

'Personal details removed' said:

"Pay our hr rate."

'Personal details removed' said:

"Funded payment should received monthly."

'Personal details removed' said:

"I need to be paid monthly instead of part at the start of term and the rest at the end of term. I have bills to pay and my own family with young children to ensure they are feed, bathed and housed."

'Personal details removed' said:

"I look after two of my grandchildren which I can not claim funding for but this family pays me - I can not afford to give free and the family can not afford not to go somewhere else to claim free childcare. Disturbing the routine and settled children"

'Personal details removed' said:

"payments need to be monthly in advance from our LA, more allowances to charge a daily rate rather than an hourly rate and be treated like an equal to a nursery that can freely do this without comeback"

'Personal details removed' said:

"That the funding is paid out on a monthly basis so I'm able to cover the basics, egbills, rent, food for my business"

'Personal details removed' said:

"To know how much we will be paid"

'Personal details removed' said:

"If the funding was paid at my hourly rate."

'Personal details removed' said:

"Pay my hourly rate. Allow the LA to pay deposits and notice periods. Make the uploading easier, surely the voucher code is enough?"

'Personal details removed' said:

"As I can only offer morning places I'm hoping there will be more children available for me .Parents hopefully will seek more childminders if they are offering the funded places"

'Personal details removed' said:

"For funding to be a higher rate. To be paid monthly instead of termly."

'Personal details removed' said:

"Monthly payments for funded places, Allowing us to charge a top up fee, Government info should call them funded spaces, rather than free, Gov should ensure childminders are mentioned in all information instead of often writing 'nursery hours"

'Personal details removed' said:

"Need local authority to change payment structure- Gloucestershire"

'Personal details removed' said:

"Clear guidance from our La about how we can charge.

The ability to be transparent with parents and charge the difference in funded payment and our hourly rate without going about it in, what is my opinion an underhanded sneaky way, I feel it is dishonest.

We should be able to charge this difference without it being voluntary and parents can choose to pay it and except our service or choose another provider."

'Personal details removed' said:

"Help understand it"

'Personal details removed' said:

"I have offered funding but I worry about not being paid monthly as I am now"

'Personal details removed' said:

"It's not free but substituted"

'Personal details removed' said:

"How much we will be paid. More clarity on what we can charge for. Will we be paid monthly"

'Personal details removed' said:

"To pay at least our hourly rate or allow us to top up without jumping through hoops. Explain to parents it's not free"

'Personal details removed' said:

"There is no such thing as free, it's subsidised. I will continue to charge as I take children out to classes such as Dance Class and Forest School class"

'Personal details removed' said:

"More suitable, appropriate, realistic hourly rate. Parents not informed its 'free childcare'"

'Personal details removed' said:

"Being paid more per hour so not giving to charge for consumables"

'Personal details removed' said:

"Being able to keep caring for family members children as at the moment we cannot claim funding, my niece will have to find a place for her son in a nursery when the funding comes in"

'Personal details removed' said:

"Increase funding payments for all age groups or limit every child to 15 hrs per week"

'Personal details removed' said:

"I think it's unfair that I am unable to charge for meals provided because my usual fees include all meals and outings etc. I try and keep my fees fair and affordable."

'Personal details removed' said:

"Clarification on exactly what the figures are going to be and how we are supposed to work it out when or if we have a change of government and they alter the system"

'Personal details removed' said:

"Better laws to protect childminders. We often encounter parents who refuse to pay fee's and think our contract's are worthless. The rigmarole to claim our fees through the small courts is exhausting. We are not treated with respect and often thought of as glorified baby sitters ! The government should be more on our side."

'Personal details removed' said:

"So far very little information gas been handed over. I have parents asking about it and I have to say to them I have no idea! Government need to Government clear guidelines and soon"

'Personal details removed' said:

"User friendly portal to help claiming for payments for these extra children easier and payments from the council to be paid on time without mess-ups and a more user friendly breakdown so it's easier to work out what payments should be"

'Personal details removed' said:

"Knowing what rate we will be paid long term for the childcare places ... all children should be paid a set 'price' for the childcare place ... after all a 2 year old doesn't cost more than a 3 year old! Also being allowed to charge a top up if the funding doesn't cover our hourly rate"

'Personal details removed' said:

"Knowing if we are being paid monthly rather than termly."

'Personal details removed' said:

"Higher funding rate. Funding not to be labelled as free as it isn't.

It also needs to be made clear to parents/carers that their rate is a lower rate than most providers usual rates and that we are taking a loss. It also needs to be made more clear it is term time only, it is unfair to expect us to go 6 weeks in summer with no wages"

'Personal details removed' said:

"Stop calling it FREE. The difference in 2y & 3yr funding rates are the difference between meeting my current hourly rate & not; so no Idea how I will charge when a child time 3 & their rate reduces."

'Personal details removed' said:

"To be paid monthly in advance for funding"

'Personal details removed' said:

"Just communication around the funding dates and funding rates for when they roll it out."

'Personal details removed' said:

"The main issue is the funding is paid twice a term so not sure how anything can help with that."

'Personal details removed' said:

"It would be beneficial for us if funding was adapted to suit childminders. As at the moment it is a scheme only made for schools to use efficiently

Also, payment dates would be an issue. Being childminders with monthly subscriptions such as childminding uk, supplies etc. being paid termly would be difficult to manage effectively."

'Personal details removed' said:

"I feel the word FREE should be removed & the word FUNDED put in it's place. I also feel the government should look after childminders in the way they look after nurseries & pre-school as parents often feel these are better option & we are therefore used as a stop gap until a nursery/pre-school place becomes available."

'Personal details removed' said:

"That parents don't pass childminders by once they don't have to pay as we are usually cheaper than a nursery so parents take the place on cost but if they don't pay may find nursery easier option as they have more cope to offer longer hrs as have more staff ratios"

'Personal details removed' said:

"funded payment made the short fall is paid by parent"

'Personal details removed' said:

"hardest part will be that parents still need to meet a criteria and may not accept there will not be enough spaces for all the children, information needs to be clear and concise for both parties"

'Personal details removed' said:

"To have these "Free" hours labelled as "Funded" rather than free and allow childminders to charge a "top up" if the funded rate does not meet the rate they charge. Currently, my local authority does not allow childminders to charge a "top up" on funded hours, which in turn could mean working below the average per hour for my area."

'Personal details removed' said:

"Childminders need to labelled as childcare professionals and people like doctors and health visitors need to understand what a great job we do for a our children to get them to be the level they need to be for school and also the parents ..they don't know enough about childminders in this sector and they don't believe still that we can do the same job as a nursery nurse"

'Personal details removed' said:

"Would be better if council paid more regularly then twice a term"

'Personal details removed' said:

"That the government make sure wording is funded/subsidised places not FREE. That there is agreements that settings can charge a fee (within reason) to keep in line with their daily fees and councils relax the rules a bit on invoicing/what we can/cannot charge for."

'Personal details removed' said:

"I have read about the average rate, but my local authority does not offer that amount and if they did then I would not need to charge the parents extra"

'Personal details removed' said:

"With the funding as long as parent top up the hourly it will be OK.. If they don't I will not be taking on funded children and will be looking for another job. As a childminder have big out goings and would not be a sustainable job any more"

'Personal details removed' said:

"Better paid funding and please stop calling it free it gives parents the wrong message"

'Personal details removed' said:

"Funding to be paid monthly is the most important thing."

'Personal details removed' said:

"Have lost lots of 3 year olds due to school offering 30 hours and before and after school care for 3 year olds. Have had to reduce my assistants hours abs wondering how my business will survive next year."

'Personal details removed' said:

"We need to ensure that funding is paid monthly, on time and correctly. They also need to make it easier to use and the headcount form needs to be more user friendly"

'Personal details removed' said:

"More children."

'Personal details removed' said:

"I need it monthly to pay my own bills especially if I have a child start after the start date it means that I'm sort until the catch up payment. Who can afford to live like that?"

'Personal details removed' said:

"Faster payment by local authority as we have to wait for it in arrears for nearly 4 weeks . I charge parents in advance which is helpful for budgeting"

'Personal details removed' said:

"We need to be able to claim expenses fairly on universal credit and we are given information but not considered in decisions"

'Personal details removed' said:

"more support for childminders and job recognition"

'Personal details removed' said:

"The funding paid rate to reflect my hourly rate"

'Personal details removed' said:

"Knowing the new funding rates to plan, there will be no places available by the time we are told"

'Personal details removed' said:

"If the government provide funded places they should pay the rate that would be charged or allow us to charge a top up fee so we do not lose money"

'Personal details removed' said:

"Information on the funding rate in plenty of time for providers to make the decision whether it is worth while"

'Personal details removed' said:

"We should not have to ask for a voluntary payment. We should be allowed to charge the difference to make up our hourly rate otherwise our businesses will become unsustainable. We do not charge that much per hour as it is."

'Personal details removed' said:

"It would help to know the funding rates"

'Personal details removed' said:

"Parents have been happy to pay a consumable fee. Most have already been paying my rate of £5.50 hour and are delighted with the saving."

'Personal details removed' said:

"The government needs to change the no funding to related children."

'Personal details removed' said:

"Monthly payments and being allowed to "top up" funding to my hourly rate. I need Hertfordshire LA to also honour my 4 week notice period as I've had funded parents just leave with no notice, I've had to pay back months worth of funding and it's left me struggling financially"

'Personal details removed' said:

"Universal credit assessment periods need to allow childminders to use the same expenses as HMRC do for self assessment tax return. They also need to lower the MIF as our hourly rate is so low unless we work at constant capacity it's hard to reach it"

'Personal details removed' said:

"Rates to be increased if not explained as free hours and explained as help towards your childcare fees"

'Personal details removed' said:

"Flexible ratios to accommodate families"

'Personal details removed' said:

"I've been childminding 17 years. In this time the government has changed our business on us without little support. I recently went over to UC and it's become a nightmare for people receiving UC who offer funded hrs as we get paid a lump sum upfront which then has a detrimental effect on my payments from UC for months.

Parents know I can only offer funded hrs if that pay a voluntary/ consumables fee to top up the hourly rate to meet what I normally charge.

The fee includes meals, snacks, outings, nappies and wipes. My parents know I cannot sustain without that support. I wouldn't be able to offer funded hrs. My business would end after 17 years of something I've put my heart and soul into."

'Personal details removed' said:

"What I'm worried about is being forced on to universal credits. I try hard to be flexible to allow parents to access funding completely free. For example one child does mon,tue one week and weds, Thurs the other. I don't charge anything on top to hold place but by universal credit standards I'd be penalised for not earning enough and would be forced to charge a holding fee"

'Personal details removed' said:

"We need a realistic hourly rate to be confirmed asap for childminders to consider sustainability and make an informed choice re their income/ future in the sector."

'Personal details removed' said:

"Being paid monthly, instead of 60% and then 40%. To be paid the same hourly rate as I charge"

'Personal details removed' said:

"I currently care for my twin grandchildren . The funding structure will mean my caring for them is in doubt . Previous grandchildren only effected 3-4 yrs , these babies are taking spaces with no income"

'Personal details removed' said:

"The 3 & 4 year old funding is below my usual rate so that would need looking at. Maybe change the wording. It should not be FREE funding it should be called something else."

'Personal details removed' said:

"As a childminder on universal credit as I am a widow with 3 small children getting paid 6 times a year is difficult as I have to pay my bills self weekly then universals credits say I can't claim until my money runs out in which they will top up but I will have zero income as my weekly money has ran out, that and the face we can not claim for gas electric water council tax, the only reason I heat my home 40 hours per week is for children, it's forcing me to give this job up"

'Personal details removed' said:

"The funding needs to be put up and should be the same everywhere"

'Personal details removed' said:

"The way universal credit looks at our income and expenses is different to how every other gov department do. We do not have any special regards. Our rate of pay is dictated by gov and we can't expand past our numbers. They are declaring our business as not profitable and making childminders look for other work despite our ability to reach minimum wage being restricted. Please look into how universal credit are looking at our finances and also local authorities need to pay childminders monthly. This should be priority before all funding comes in sept 2024."

'Personal details removed' said:

"The funded fees the local authority pay me is less than what my fee is to non funded children.

This impacts universal credit as the minimum income floor is based on earning minimum wage but as a childminder we have lots of outgoing that take us below this do universal credit say its not a viable business. Universal credit do not understand that we can only take in a set number of kids per ratio and that our own children are included in these numbers until they are 16. Universal credit work the minimum income floor based in working 52 weeks but self employed do not get paid when sick or on holiday. Childminders are going to leave the profession they love because they are being penalised due to universal credit not understanding our business"

'Personal details removed' said:

"Please, please, please advocate for Childminders on Universal Credit.

Not being able to use the same approach to expenses as the HMRC childminding agreement is crippling and causing huge financial hardship. The 10% wear and tear allowance and utilities are just two of the expenses that UC will not allow.

Lots of single parents provide high quality childcare and education, but we will be better off employed at a minimum wage job

Please campaign for monthly payments for funding by all LA's"

'Personal details removed' said:

"Lobby the government to call funding subsidised not free and pay it into the parents childcare choices account so they can then use it with any registered provider. There's no need for the complicated and convoluted local authority model currently used.

I also believe funding should be means tested on a sliding scale based on household income. Two people earning £99'000 each should not get the same as 2 people earning minimum wage."

'Personal details removed' said:

"Its the sudden drop in funding for 3/4 yr olds which i find incredible"

'Personal details removed' said:

"We require payments in advance not in arrears. We are unable to manage financially if we have more than 2 funded children."

'Personal details removed' said:

"The local authorities putting out their fees before the end of January so we all know what the hourly rate will be."

'Personal details removed' said:

"Proper funding rates. The gov to stop calling it free. The agreement if each LA to pass on the money received from gov. Monthly in advance payments."

'Personal details removed' said:

"I believe that this isn't 'free' childcare. The LA take a cut before it comes to the childminder. Once that happens there is a short fall between the fee given and our hourly fee. I think this needs to be explained to parents more thoroughly."

'Personal details removed' said:

"Support is advertising funding as funding and not free!!! Support is paying providers monthly or termly in advance not expecting providers to fit the shortfall until the payment is made. Also if parents leave half way through the term and moves to an alternate provider, the original provider shouldn't have to loose out cause the funding is all passed over to the new provider leave if the original provider out of pocket. Support is like any other business, parents needs to give 4 weeks paid notice when they intend leaving a provider. As a business which shouldn't have to jump through hoops to cover the loss in funding, keep it simple the family get x per month, anything outstanding to the provider should be paid by the family, not providers having to work out voluntary contributions or Consumables to charge to work out fees or to lessen their loss in income."

'Personal details removed' said:

"Higher hourly rate and able to charge for extras"

'Personal details removed' said:

"Monthly payments at the moment it is termly. I cannot sustain that"

'Personal details removed' said:

"Despite not currently asking for contributions I do feel like the current manner in that funding is paid will cause not only myself but all settings to have significant financial difficulty. The amount of issues north Northamptonshire providers see with funding payments being incorrect each month is worrying if 100% of income is relied on those payments. It is also a very big concern on the amount that will be given to providers and needs to be significantly higher than what is currently given. It is unfair to portray to parents that childcare is FREE when it continues to be completely underfunded. The government needs to advertise it as funded hours and completely remove the term FREE. It's also important for them to be transparent to parents and explain that a percentage of the money given towards each child for funded places is removed by the local authority."

'Personal details removed' said:

"Equal fair hourly rates"

'Personal details removed' said:

"Higher funding payments for 3 and 4 year olds.. In Somerset only £4.97 per hour.. Too low."

'Personal details removed' said:

"The council need to make it easier and stop emailing us on bank Holidays or the last day of term at 5pm for example. Their emails are annoying and you then have to log on separately to check the email that was not important. The pay is rubbish and I shouldn't have to justify how I spent the money..."

'Personal details removed' said:

"i have decided to leave childminding all together"

'Personal details removed' said:

"Not be dictated to by the government what I can charge. Communication between government and HMRC to receive universal credit to make up a living wage"

'Personal details removed' said:

"I would like to be paid what my current rate is. At the moment I am not. I would also like to be paid monthly as I have bills to pay."

'Personal details removed' said:

"I object to the council paying us less than we charge and not being allowed to charge parents for the difference. All the parents are horrified that we have to take a cut in wages just so they can get free childcare and they would willingly pay the difference. I don't mind how much we are paid as long as I can charge the difference."

'Personal details removed' said:

"None really but it would be so much easier if they stated it was funded hours and not free. Also I will never be able to care for my own grandchildren, this really needs to change"

'Personal details removed' said:

"Local authority needs to let parents know childminders are Just as valuable"

'Personal details removed' said:

"change the free word, its not free but subsidised"

'Personal details removed' said:

"A confirmed hourly rate. I would like confirmation that we can top up our FEEE hours."

'Personal details removed' said:

"For parents to understand paying the extra helps towards extra educational items and also to pay our own bills. The work we do to make the children exceed before starting school as we are not seen as professionals like nurseries"

'Personal details removed' said:

"Funding days to be set by local authority without having to work this out and complete a long form. Payment on the 1st day of each month for each funded child just like a parent would pay"

'Personal details removed' said:

"I am struggling with the funding being paid in blocks !! We need monthly payments here in Essex . My partner is also self employed and it's been so difficult!

So once funding is introduced from earlier ages, this is going to be a massive problem. .how can I run a house waiting constantly with no other money coming in if parents can't pay the voluntary amount?

Very worrying times x"

'Personal details removed' said:

"I only accept 1 funded child per year. It's getting harder to keep my business sustainable with rising costs. My funding amount for 3/4 is less than my hourly rate. 2 year funding is better but in my experience parents think they can only access this if they send their child to nursery. Childminders need a big national campaign to promote our worth & value."

'Personal details removed' said:

"I feel being paid monthly rather than termly, and not being paid less than my usual rate would support my business to remain financially viable if more/all children will be accessing funding."

'Personal details removed' said:

"I always read emails from places like yourself which i do find really informative, thank you . Just any tips , updates would be great."

'Personal details removed' said:

"I would like the funding rate to be what are fees are so we not having to ask for anything else's. Lot parent only want the 15 hrs per week"

'Personal details removed' said:

"Remove the word free as it really isn't unless the government want to pay more an hour"

'Personal details removed' said:

"Any advice /support from cm Uk / government would be greatly appreciated"

'Personal details removed' said:

"A clear and concise document on how we can structure payments (and knowing what the funding structure will be)"

'Personal details removed' said:

"Funding for own children taking up a space in the setting. And to receive the amount of funding for it to be FREE to parents without LA taking their cut"

"Higher fee rates."

"No children allowed to swap provider part way through the term, I've ended up paying back £150 because a preschool place came up."

"To know the exact rates we will be paid and how the payments will be made."

'Personal details removed' said:

"Call it funded & let settings simply take that amount off their fees. It could be so simple and no one would loose out."

'Personal details removed' said:

"The rate must increase with each persons needs, as happens in all business."

'Personal details removed' said:

"The amount we are going to be paid. My LA hasn't decided yet. Also being paid on time - my LA is often late paying."

'Personal details removed' said:

"To be paid my hourly rate of £4.75 and no less!"

'Personal details removed' said:

"If the rates are what they have said then it will be ok, the only problem is that they often make mistakes and pay in arrears when this is most of my income it will be more of an issue. I'm concerned at being at the will of the council."

'Personal details removed' said:

"Same finding for all ages. As a childminder we only have 3 spaces and need a reliable income throughout all ages of children. They start at 9m and stay until school and I can't have my income halved just because child turns 3 years old"

'Personal details removed' said:

"Allow us to charge the difference. Also, decreasing the amount as the child gets older (and potentially costs more to care for) doesn't make sense."

'Personal details removed' said:

"The only thing I'm worried about, which actually isn't my problem, but there isn't enough childcare providers who have space for all these new children who will be entitled to childcare. I am full with a waiting list, until Sept 2025. I intend to quit minding in 2026"

'Personal details removed' said:

"Better funding rate for 3/4 yr olds."

'Personal details removed' said:

"Our funding is every 3 months payments, needs to be monthly"

'Personal details removed' said:

"The Government ti support Childminders with Grants or some form of financial assistance."

'Personal details removed' said:

"We are currently challenging our LA to pay funded hours monthly rather than in a 70/30 split twice a term. It would be useful for central Government to say that LAs MUST do this if requested"

'Personal details removed' said:

"It would help if we weren't paid in arrears as if all children are funded will have to wait a while before payment which will leave us very short. Also parents need to be made aware that funding may not cover all their hours and outings etc this will cause us many unpleasant conversations."

'Personal details removed' said:

"More Flexibility in the how & what we charge as we are supposed to be Self employed and therefore should be able to have the flexibility to offer a rate suitable for what individual service we ate offering."

'Personal details removed' said:

"We need to know exact funding rate we will receive for our area. This needs to match our hourly rates and increase inline with cost of living. We also need this to be paid in advance and not arrears or have something financial in place for the first term until payments have been made if they continue to be in arrears."

'Personal details removed' said:

"I think parents should be made aware on sign up to these hours that providers may need to charge to make up to their hourly rate."

'Personal details removed' said:

"Pay the childminders their own rates. They're set at that for a reason!"

'Personal details removed' said:

"The government need to find a better way of supporting the childminders as well as the families that need the support. We are the life line for parents so we should have a bigger say in how we run our business."

"I live in a deprived area so the funded rate is equal to my hourly rate."

'Personal details removed' said:

"pay my hourly rate so I don't need the extra payment from parents make it clear to parents that funding is for 38 weeks of the year."

'Personal details removed' said:

"The fact our funding is paid in on lump at the end of the month it is submitted means it's a late payment and struggling though that month for money. Also the that other councils pay childminders In monthly instalments which is easier to budget."

'Personal details removed' said:

"To know what other childminders charge"

'Personal details removed' said:

"I can't find any information from Surrey council. It would be helpful if councils were more informative."

'Personal details removed' said:

"Same amount for all ages not taking a funding cut once child reaches 3. We can only have 3 max under 5..."

'Personal details removed' said:

"The actual amount per hour my LA will be giving us as opposed to the government."

'Personal details removed' said:

"I think schools will expand to offer 2 year places and I dont want to provide only wrap around care"

'Personal details removed' said:

"The amount of children on it will effect my business"

'Personal details removed' said:

"Our local authority is known for getting it wrong. So with a full setting all funded i risk months where no payment is made or is incorrect. So having a mixture ensure i have some money to survive with"

'Personal details removed' said:

"Universal credit scrapping the minimum income floor for childminders and allowing us to claim our full expenses

To be paid full amount monthly in advance and to tell parents it's not free childcare there will be additional costs depending on your provider"

'Personal details removed' said:

"Pay monthly"

'Personal details removed' said:

"The amount going to be paid per child per hour to be open and honest including to parents in the LA so they can see if there is a gap between the usual fees.

The best possible scenario would be for the gov to fund via the childcare choices so I could invoice parents as usual and they transfer a combination of 'funding', tax free childcare and personal bank transfer.

There is also a situation not being mentioned via this, is out of 3 children / families attending I believe 2 will not be eligible due to the higher earnings thresholds, so perhaps I don't need to worry too much!"
